The teacher on such leaves or deputation as mentioned above shall not be put to any disadvantage for promotion under CAS due to his/her absence from his/her teaching responsibilities subject to the condition that such leave/deputation was undertaken with the prior approval of the competent authority following all procedures laid down in these regulations and as per the acts, statutes and ordinances of the parent institution.

(ii)	Papers with impact factor less than 1	-	10 Points
(iii)	Papers with impact factor between 1 and 2	-	15 Points
(iv)	Papers with impact factor between 2 and 5	-	20 Points
(v)	Papers with impact factor between 5 and 10	-	25 Points
(vi)	Papers with impact factor above 10	-	30 Points.

- a) Two authors: 70% of total value of publication for each author
- *b) More than two authors: 70% of total value of publication for the First/Principal/ Corresponding author and 30% of total value of publication for each of the joint authors.*
- Joint Projects: Principal Investigator and Co-investigator would get 50% each.
- Paper presented can be claimed only once if it is a part of edited book and/or proceedings.
- For joint supervision of research students, the formula shall be 70% of the total score for Supervisor and Co-supervisor, both shall get 7 marks each.
- *For the purpose of calculating research score of the teacher, the combined research score from the categories of 5(b)on Policy Document and 6on Invited lectures / Resource Person/Paper Presentation below shall have an upper capping of thirty percent of the total research score of the teacher concerned.
- The research score shall be from the minimum of three categories out of six categories.
