

FOREWORD

Dr. B. R. Ambedkar Open University established GRADE in 2001 to promote system development in Open Distance Learning (ODL). As a system development agency, GRADE, in addition to undertaking/promotion of research, has other objectives such as conducting seminars, workshops and training programmes, collaborating with institutions and agencies for networking in India and abroad, offering international fellowships and conducting system evaluation studies. Creating an exhaustive database on ODL in the regions /countries and providing researchers access to this data is yet another important objective of GRADE.

The development and effectiveness of the ODL system depends on quality assurance processes in place in the different subsystems of ODL. The Quality Assurance Cell was established as a consequence, with a view to create a nodal agency to promote quality assurance.

GRADE has identified important areas that focus on the various operations in ODL and has developed performance indicators and performance ensuring measures for the same. It is felt necessary to publish these performance indicators as a series and disseminate the information for the benefit of the different functionaries engaged in this new system – the ODL system.

QUALITY ASSURANCE

In recent years, increasing attention has been paid to the issue of quality in higher education, non-formal education and in open distance education. The migration to a distributed learning environment significantly heightens the need to assure quality. Distributed learning brings the potential of increased volume of students, increased staff reliance on technology, and increased partnership with external organizations. There are, quite simply, far more stakeholders in the mix. A robust distributed learning programme will typically involve instructors, programme administrators, and instructional designers familiar with the new media, technicians, evaluation specialists, student support staff and local facilitators.

Distance education takes a learner-centered approach rather than the traditional content-centered approach of textbooks. The key is the student. Learners need to become involved and motivated by the material and to take ownership of the skills and knowledge that they acquire.

Without guidelines and procedures designed to assure quality in the design, development and deployment of the learning material and the management of all processes towards that end, an organization runs the risk of disseminating courses that are, at best, effective but which do not serve the organization's mission. Poorly designed and delivered courses reflect badly on the organization's learning and assessment outcomes.

Performance ensuring measures for quality management and administrative
practices; and
Research and development systems and the established benchmarks/guidelines
