O R D E R:

In the Government Orders 1st to 4th read above, orders have been issued granting the following (2) concessions to the hearing impaired, orthopedically handicapped and visually challenged students studying in Engineering, Pharmacy, MBA & MCA courses:-

- (i) Exemption from payment of examination fee.
- (i) Reduction of pass marks in each subject by 10%.

2. In the reference 5th read above, Sri Vasudeva Sai Rajesh, S/o. Sambasiva Rao, R/o. Kakinada has requested to consider for extending same benefits / concessions to the students of B.A., B.Sc., and B.Com courses on par with the students, who are pursuing MBA, MCA, Engineering and Pharmacy courses.

3. The Government after careful examination of the entire matter, hereby order to extend the same concession mentioned in para (1) above to the hearing impaired, orthopedically handicapped and visually challenged students studying B.A/B.Com/B.Sc courses (i.e., all degree course studying students) with immediate effect.

4. The Commissioner of Collegiate Education, Andhra Pradesh, Hyderabad and Registrars of the Universities in the State are requested to take necessary further action in the matter.
