With reference 1st & 2nd cited, this office collected E-waste pertaining to various branches of the University. Necessary certification for the destruction of data in all the CPUs and the items i.e. CPUs, Monitors, Printers, UPSs, batteries, for non-working and unrepairable condition is enclosed. The details E-waste material are:

 CPU is not working - 	347 Numbers (23CPUs at RCCs)
2) Monitors not working -	347 Numbers (23 Monitors at RCCs)
3) Not working Printers -	229 Numbers
4) UPS Batteries -	40 Numbers (5KV UPS Batteries)

Sub:- Computer scrap disposal - Reg.

The University has constituted a four member committee with Asst. Registrar (Accounts), Asst. Registrar (Administration), Computer Programmer and In-charge, Computer Centre) in 2009 for the disposal of computer scrap. The Committee first met on 16-7-2009 and resolved to segregate the unused/non-working computer systems, printers and UPSs, etc. and dispose them as scrap. Accordingly the computer centre has identified 347 CPUs, 347 monitors, 229 printers, 242 UPSs, and 40 UPS batteries as scrap for disposal.

Meanwhile the Govt. of Andhra Pradesh has issued G.O. M.S. No.24 (dt.3.9.2010) of Information & Communication Department authorizing APTS for disposal of E-Waste. Accordingly, the Committee consisting of In-charge Computer Centre, Programmer, Technical Advisor to Computer Centre and Asst. Registrar (DMP) met on 22-3-2013 and recommended to dispose the computer scrap under E-Waste project of APTS. (Copy of minutes enclosed)

The Committee has identified the following scrap in the University to be cleared with the help of E-Waste team of APTS:

- 1) Computer Systems 207 Numbers (including 207 Monitors and 207 CPUs)
 - a) 32 Nos of Delldot purchased in the year 1998 with 64 MB RAM, 4 GB HDD, P2, CRT monitor.
 - b) 75 Nos of Compaq Systems purchased in the year 1999 with 128 MB RAM, 10 GB HDD,P3, 15" CRT monitor.
 - c) 100 Nos. Dell make systems purchased in 2002 with 256 MB RAM, 40 GB HDD,P4, 15" CRT monitor.

- Printers 229 Numbers purchased in different years and in not working condition. (List is enclosed).
- 550 VA/600VA/1KV/Stabilizers UPSs 342 Numbers purchased in different years and not in working condition and small UPSs with discharged batteries (not working). List enclosed.
 - 2 Numbers of ADF Scanners purchased in 2002 from Fujistu company.
 - Dell Power edge Servers 8 Numbers not working purchased in the year 2003.
 - 6) Dell Work stations 5 Numbers purchased in the year 2003.
 - Any Cable pieces unused/ damaged (Cat 5 cable pieces/ damaged power cables/ any interface cables) found in scrap.
 - 8) Burnt/ damaged/ un reparable LAN equipment (LAN switches, hubs, etc).
 - 9) All the old plastic items including used toner cartridges, printer ribbons, etc.

The Committee recommended that old/ non-working UPSs with 5 KV, 7KV and 11 KV capacity along with batteries 100 AH / 40 AH (maintenance free) be disposed with the help of other Vendors (UPS manufacturers, UPS dealers, etc.), if the E-Waste project of APTS unable to clear the UPSs scrap. As the APTS may also clear UPS scrap, the following UPS related e-waste may be entrusted to APTS:

- a) 4 Numbers of 5 KV UPSs purchased in 2002 (Computer Center, AVPRC, COE, SSB) and its batteries approximately 40 Numbers.
- b) 1 Number of 7.5 KV UPS purchased in 2003 and its batteries 12 Numbers.
- c) 2 Numbers of 5 KV UPSs purchased in 2007 and its batteries 24 Numbers.
- d) 4 Numbers of 11 KV Delta UPS purchased in 2008 with 80 maintenance free batteries.

Further, it is certified that the data in all the CPUs have been destroyed and the items (i.e., CPUs, monitors, printers, UPSs, and batteries) are non-working and un-reparable condition. Therefore, the all the above items may be treated as scrap and arranged for disposal,
