Keeping this in view, it is proposed to establish Learner Support Services Centre Dr.BRAOU at AOC Centre and include the above mentioned additional Course Programmes for serving personnel of AOC and their dependents.

Responsibilities of BRAOU

1. Dr. BRAOU would provide proficient staff as required to run Learner Support Services Centre of Dr. BRAOU at AOC Centre, Secunderabad.
2. Dr. BRAOU would provide all academic inputs and administrative support for smooth functioning of the Learner Support Services Centre of Dr. BRAOU.
3. Dr. BRAOU would actively engage in continuous monitoring of the programme right from the entry level to the award of Diploma / Advance Diploma / Degree and Postgraduate Degrees.
4. The entire evaluation process would be the exclusive duty of the University culminating in the award of the Certificates / Diplomas/ Degrees after collection of the requisite fee.
5. Dr.BRAOU exempt the payment of tuition fee to the personnel of AOC, but however they have to pay the cost of the course material supplied to them and also payment of examination fee as prescribed by Dr.BRAOU.

Responsibilities of AOC Centre

1. AOC Centre would conduct the Course Programmes at Learner Support Services Centre of Dr. BRAOU located in their premises using their own resources.
2. AOC Centre would continuously maintain Management Information System (MIS) to facilitate exchange of information / inputs for improving the training process.
3. AOC Centre would enrich the trainees who have already left the Centre after completing the training at the AOC Centre, Secunderabad with additional inputs and bring them at par with the current batch of trainees to enable them to enroll along with the current batch for admission and examinations.
4. The AOC personnel dependants have to pay the tuition fee and examinations fee as prescribed by Dr.BRAOU.
